[How is the scholarship applied or reimbursed?](#)

PVA has set-up a master account with the hotel. The scholarship nights will be charged to the master account. Reimbursement will not be provided directly to the scholarship recipient.

[Is PVA a vendor to the VA?](#)

No, PVA is not a vendor to the VA.

[What is included in PVA's scholarship?](#)

This year, the scholarship will cover up to 3 nights hotel stay only at the Gaylord National Resort and Convention Center.

[Will there be confirmation sent if you are among the 500 who qualify for the 3 nights hotel scholarship?](#)

Once you complete registration, you will receive a confirmation email stating your request was received. Once your information completes the approval process, you will receive a scholarship award letter by

email.

[Will I be considered for PVA's scholarship if my registration fee is not paid in full?](#)

Your application will not be reviewed until your registration fee is paid in full.

[Do I apply for the scholarship separately?](#)

The scholarship is part of the online registration process. You must fully register to be considered for a scholarship.

[If I am not awarded a scholarship or cannot attend, can I still be reimbursed the \\$100 registration fee?](#)

Reimbursement will be granted on a case by case basis.

[If I qualify for a scholarship and later must cancel for unforeseen reasons, will I be reimbursed the registration fee?](#)

This will be evaluated on a case by case basis.

[Is there a designated conference hotel?](#)

The designated conference hotel is the Gaylord National Resort and Convention Center.

[What is the group rate?](#)

The group rate is \$169 per night.

[When will my credit card be charged?](#)

You must hold your Hotel Reservation with a credit card, however, it will not be charged until Check-In (or Cancellation Fee within 24 hours of arrival).

[What are the conference dates?](#)

The conference will be held August 29 - 31, 2017.

[What is the reservations procedure?](#)

Please use the main menu located on the top of the site to locate [Registration](#) [3], [Scholarship Information](#) [4], and [Hotel Reservation](#) [5] information.

[If I choose to stay at another hotel, will PVA reimburse me for the hotel?](#)

No, PVA has established a block of rooms at the [Gaylord National Resort and Convention Center](#) [5] and will not reimburse or provide credit for any other hotel.

[If I choose to share my room with another scholarship recipient, how is the scholarship applied?](#)

The scholarship applies to the room nights only. So, in the case of a room share **one (1) scholarship is applied to the room.**

[What is the refund policy?](#)

Requests for refunds must be submitted in writing to summit@pva.org [6]. Refunds of 50% may be granted upon approval if received before April 1, 2017. **After April 1, 2017 refunds will not be granted for cancellations or no-shows.**
